- A. Information: Presentation of Plaque to Santos Vigil
Mayor Mendoza thanked Mr. Vigil for 21 years of service to the City of Woodlake and its residents.
- B. Action: Proclamation from the City of Woodlake, Proclaiming A Community for Child Well Being
Ramona Chiapa, Executive Director reported the following: every child is entitled to live in a peaceful community, to feel secure and to be free from violence, from abuse and neglect, and from lack of concern for their well-being. All children are entitled to be loved, cared for, nurtured, and encouraged to reach their full potential. Ms. Chiapa stated she is happy to recognize the City of Woodlake as a city who aims to be a community that provides the best quality of life for all its citizens, and supports positive efforts to support this goal. Woodlake acknowledges that the sacrifices and service of its veterans was to insure peace and well-being of all the

residents of Woodlake and this nation, particularly the children. Our communities are stronger when all citizens become aware of their responsibility to all children and support parents to raise their children in a safe and nurturing environment.

ON A MOTION BY MARTINEZ, SECOND BY ORTIZ IT WAS VOTED TO APPROVE THE PROCLAMATION AND PROCLAIM THE CITY OF WOODLAKE AS A COMMUNITY FOR CHILD WELL BEING. APPROVED UNANIMOUSLY.

PUBLIC HEARING

City Administrator Lara reported the following: it was determined that as part of the construction of the South Valencia ADA project the City would need to acquire forty four (44) separate parcel slivers. The right-of-way acquisition will allow for the construction of curb, gutter, sidewalk and storm drain improvements on South Valencia Blvd. from Bravo Avenue south to the Wutchumna Ditch. The City contracted with Hamner, Jewell & Associates to assist with the acquisition of the properties. The City has successfully acquired forty two (42) of the forty four (44) parcel slivers. The City has provided the owners of the properties that have not been acquired with a formal offer and an appraisal. The owners at 493 N. Valencia Blvd., with APN No. 060-250-035 have two willing sellers but the third owner of the property has been unresponsive. For the property located at 384 S. Valencia Blvd., with APN. 061-181-103 the City has received no response.

- A. Information: Items from Staff

City Employee Waters – Reported notices were mailed to residents who have been flagged by the water meter system as having a leak. Staff wanted to allow residents to fix any leaks before the new billing starts on July 1st.

City Administrator Lara – Reported the roundabout has been open and operational for about 2 ½ weeks and there have been no issues. Businesses are also doing well and there have been no issues for them. Councilmember Ortiz asked if West Naranjo Street would be repaired. City Administrator Lara stated Caltrans has a schedule of street repairs and he was not sure when Naranjo would be repaired. Councilmember Martinez asked what would be placed in the middle of the roundabout. City Administrator Lara stated there would be landscaping but nothing that would interfere with driver's vision. Also, Councilmember Martinez asked if the sidewalk at Valencia and Bravo would be finished. City Administrator Lara stated yes. The workers ran out of material so more needed to be ordered. Councilmember Ortiz asked if the bollard lights could be dimmed. City Administrator Lara stated no. City staff reached out to the various services clubs and

asked for a donation to help purchase flags to decorate the new light poles downtown for various patriotic holidays. The Woodlake Lions and Homegrown Project both made a donation for the purchase of the new decorative flags.

Chief Marquez – Reported a home robbery occurred on Friday, June 10th. Suspects were arrested and stolen items were returned to rightful owner. Firework sales will begin July 1st and end July 4th. Residents may light fireworks during that time. Also, Chief stated that at the council meeting on May 23rd, Councilmember G. Gonzalez Jr. had reported to council that the sober grad committee was seeking donations for the sober grad event for the graduating seniors. Chief Marquez stated he would make a personal donation and also ask Woodlake Lions Cub and City Administrator Lara stated that he would ask the Homegrown Project if they would also donate. Chief Marquez and City Administrator Lara asked for a letter from the committee for the donation but one was never given to either Marquez or Lara. On June 10th, a member from the sober grad committee was trying to collect donations but since no letter was received, Woodlake Lions could not give their donation.

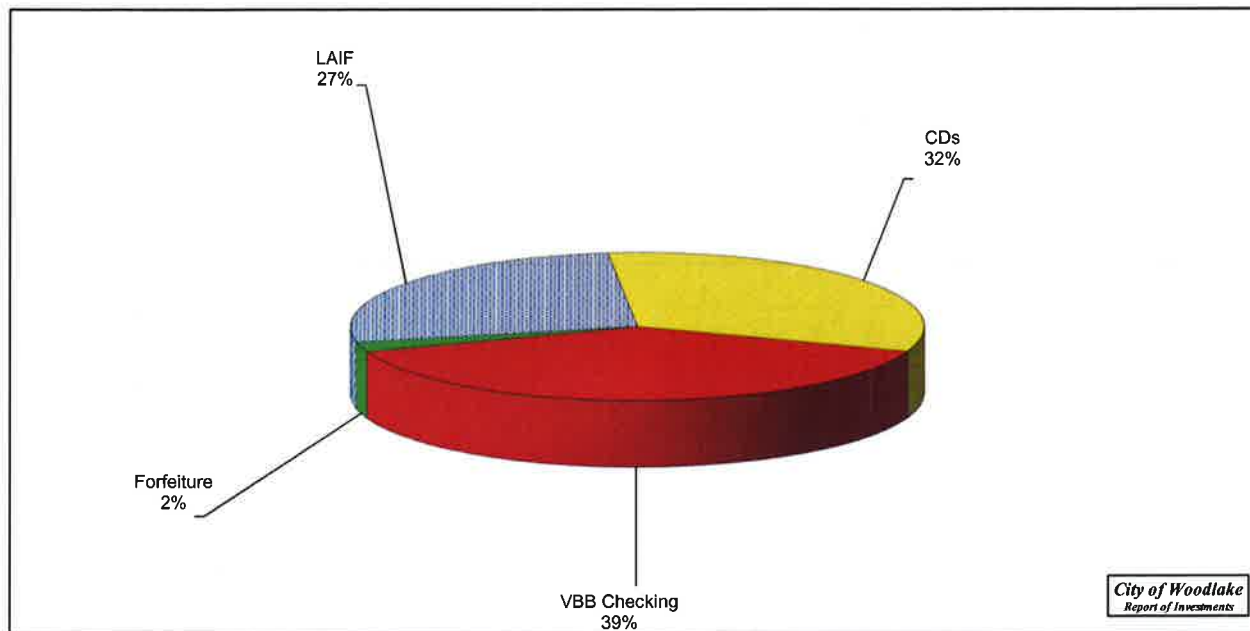

BACKGROUND:

Annually, as part of the Landscape and Lighting Act of 1972, Council sets a public hearing date for those wishing to comment on any of the individual assessment districts in the City of Woodlake. This year that date will be set as July 25, 2016. All assessment district property owners have been notified of the public hearing date and location. Prior to any action by the City Council, the City Engineer develops an engineer's report that breaks down the costs necessary to maintain each assessment district. Reports have been developed for the following districts: Parkwood, Gentle Hills, Olive Estates, Castle Rock Park, Olive Vista and Castle Rock Park Phase II. Copies of the reports are attached.

DISCUSSION:

The individual engineer's reports, for each assessment district, break down the costs necessary to maintain each district. The costs have not changed from the previous year. The assessment allows for maintenance of grounds and lights plus incidental costs such as administration and engineering. Districts are maintained by City staff. A majority of the expenditures go towards basic maintenance. Currently, staff is revamping the sprinkler systems and will replant shrubs and trees as necessary in all the districts.

The costs for each individual property owner are as follows:

Parkwood: \$197.50

Gentle Hill Estates: \$198.40

Olive Estates: \$172.44

Castle Rock Park: \$171.00

Olive Vista: \$200.00

Castle Rock Park Phase II: \$177.50

At the July 25, 2016 City Council meeting, a public hearing will be held for all property owners of the assessment districts wishing to comment on their district.

RECOMMENDATIONS:
